PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners are accused and apprehending arrest at the hands of the respondent Police, in Crime No.15 of 2014, for the alleged commission of offences punishable under Sections 147, 148, 294(b), 324 and 506(ii) of I.P.C., seek anticipatory bail.

2. The learned counsel appearing for the petitioners would submit that the petitioners are nothing todo with the alleged commission of offences and they have been falsely implicated.

3. The learned Government Advocate (crl.sie) would submit that the Injured has been discharged from the hospital.

4. This Court, taking into consideration of the above facts and circumstances of the cases, is inclined to enlarge the petitioners on anticipatory bail. Accordingly, the petitioners are ordered to be released on bail in the event of arrest or on their appearance before the learned Judicial Magistrate, Pappanasam, Thanjavur and on executing a bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties each for a like sum to the satisfaction of the learned



petitioners shall appear before the respondent police daily at 11.00 a.m., for a period of two weeks and thereafter as and when required. The petitioners shall comply with the condition stipulated under Section 438 Cr.P.C. scrupulously.

WEB COPY 5. The petitioners shall appear before the concerned Magistrate within a period of 15 days from the date on which the order copy made ready failing which, the petition for anticipatory bail stands dismissed.
