PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER: The Court Made the following order:-

The petitioners herein are anticipating arrest in respect of the offences under Sections 147, 148, 294(b), 427, 447 and 506(ii) I.P.C., in Crime No.438 of 2014 on the file of the respondent police and hence, seek anticipatory bail.

- 2. Heard Mr.A.Baskaran, learned counsel appearing for the petitioners and Mrs.S.Prabha, learned Government Advocate (Criminal side) appearing for the State.
- 3. The learned counsel appearing for the petitioners would submit that the petitioners are innocent persons and they did not commit any crime as stated in the complaint and they have been falsely implicated in this case. He would also submit that no prejudice would be caused to the prosecution in the event of the petitioners' release on anticipatory bail. Hence, he would pray for the grant of anticipatory bail, assuring that if the petitioners are released on anticipatory bail, they would not either tamper the witnesses or hamper the investigation.
- 4. The learned Government Advocate (Criminal side) has no serious objection for granting anticipatory bail in favour of the petitioners. According to her, nobody has sustained injury in the occurrence.

Court is inclined to enlarge the petitioners on anticipatory bail subject to the following conditions.

6.Accordingly, the petitioners are ordered to be released on bail in the event of arrest or on their appearance before the learned Judicial Magistrate No.I, Kuzhithurai, and on each of them executing a bond for a sum of Rs.10,000/- (Rupees Ten thousand only) with two sureties each for a like sum to the satisfaction of the learned Magistrate concerned and on further condition that the petitioners shall appear before the respondent police once in a week i.e., Monday at 10.30 a.m. until further orders. The petitioners shall comply with the condition stipulated under Section 438 Cr.P.C. scrupulously.
