PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER: The Court Made the following order:-

The petitioner apprehends arrest for the offences punishable under Sections 147,148,342,294(b),323,307 and 506(ii) of IPC in Crime. No.108 of 2014 on the file of the respondent police, seeks anticipatory bail.

 - (i) Anticipatory bail granted to the petitioner;
- (ii) Petitioner shall surrender before the learned Judicial Magistrate-I, Thirunelveli within a period of fifteen days from the date of receipt of a copy of this order, failing which, the petition for anticipatory bail stands dismissed;
- (iii) Petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten thousand only) with two sureties each for a like sum to the satisfaction of the above said Magistrate;
- (iv) Petitioner shall appear before the respondent police twice a day daily at 10.30 a.m and 5.30 p.m until further orders.
- (v) The petitioner shall comply with the condition stipulated under Section 438 Cr.P.C. scrupulously.
