PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner apprehends arrest for the offences punishable under Sections 147,148,342,294(b),323,307 and 506(ii) of IPC in Crime. No.108 of 2014 on the file of the respondent police, seeks anticipatory bail.

2. The learned counsel for the petitioner submitted that the co-accused has already arrested and released on bail by the Sessions Court.

3. Heard the learned Govt. Advocate (Crl. Side).

4. Considering the facts and circumstances of the case and also considering the fact that the co-accused has already granted bail, I am inclined to grant him anticipatory bail.

5. Ordered as under:-

(i) Anticipatory bail granted to the petitioner;

(ii) Petitioner shall surrender before the learned Judicial Magistrate-I, Thirunelveli within a period of fifteen days from the date of receipt of a copy of this order, failing which, the petition for anticipatory bail stands dismissed;

(iii) Petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten thousand only) with two sureties each for a like sum to the satisfaction of the above said Magistrate;

(iv) Petitioner shall appear before the respondent police twice a day daily at 10.30 a.m and 5.30 p.m until further orders.

(v) The petitioner shall comply with the condition stipulated under Section 438 Cr.P.C. scrupulously.
