PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER: The Court Made the following order:-

The petitioners apprehend arrest for the offences punishable under Sections 147,148,294(b),323,324 and 307 of IPC in Crime. No.517 of 2014 on the file of the respondent police, seek anticipatory bail.

- (i) Anticipatory bail granted to the petitioners;
- (ii) Petitioners shall surrender before the learned Judicial Magistrate-II, Ramanathapuram within a period of fifteen days from the date of receipt of a copy of this order, failing which, the petition for anticipatory bail stands dismissed;
- (iii) Each of the Petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten thousand only) each with two sureties each for a like sum to the satisfaction of the above said Magistrate;
- (iv) Petitioners shall appear before the respondent police twice a day daily at 10.30 a.m and 5.30 p.m until further orders.
- (v) The petitioners shall comply with the condition stipulated under Section 438 Cr.P.C. scrupulously.
