PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who is arrayed as A.1, apprehends arrest at the hands of the respondent police for the alleged offence punishable under Section 306 I.P.C. in Crime No.93 of 2014 on the file of the respondent police and hence, seeks anticipatory bail.

2. The case of the prosecution is that the deceased was doing real estate business and also finance business and gave some amount to the petitioner/A.1 and another, who are conducting chit fund business and they have not returned the money and on that score, the deceased committed suicide and hence, a case has been registered against the petitioner.

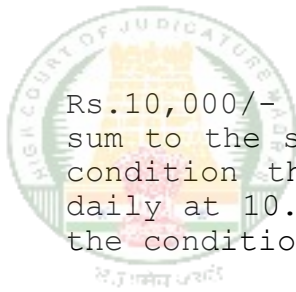
3. It is submitted by the learned Counsel for the petitioner that the petitioner is innocent and he has not committed any offence as alleged in the F.I.R.

4. Heard the learned Government Advocate (Crl.Side, who submitted that the petitioner is A.1 and he is doing Chit Fund business and the deceased gave some money to the petitioner, which was not returned by him and hence, the deceased committed suicide.

5. Considering the facts and circumstances of the case and also considering the fact that there is no overt act as against this petitioner as required under Section 107 I.P.C. for abetting the suicide and this Court also granted anticipatory bail to the co-accused in Crl.O.P.No.3836 of 2014, this Court is inclined to grant anticipatory bail to the petitioner, with certain conditions.

6. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance before the learned Judicial Magistrate NO.I, Tirunelveli and on executing a bond for a sum of



Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Magistrate concerned and on further condition that the petitioner shall appear before the respondent police daily at 10.30 a.m. until further orders. The petitioner shall comply with the conditions stipulated under Section 438 Cr.P.C. scrupulously.

7. The petitioner shall appear before the concerned Magistrate within a period of 15 days from the date on which the order copy made ready, failing which, the petition for anticipatory bail stands dismissed.
