PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner is the Accused No.5 and he was arrested by the respondent police on 17.02.2014 for the alleged offences punishable under Sections 323, 365, 147, 148, 364 and 302 of I.P.C., in Crime No.44 of 2014 on the file of the respondent police and hence, seeks bail.

2. It is submitted by the learned counsel for the petitioner that the name of the petitioner is not found in the F.I.R. and only on the basis of the confession given by the co-accused, the petitioner has been implicated in this case and he was arrested on 17.02.2014. Therefore, he may be released on bail.

3. It is submitted by the learned Government Advocate (Crl.side) that there was a dispute between the deceased and the accused Nos.1 to 4 regarding love affair, thereby the accused Nos.1 to 4 with the help of other accused persons have committed the offence of murder and the petitioner is implicated on the confession of the co-accused and he is



arrayed as A5. He also submitted that on the basis of the complaint given by the father of the victim, the case has been registered and the investigation is still pending.

4. Considering the fact that the name of the petitioner is not found in the F.I.R. and only on the confession of the co-accused, the petitioner has been implicated in this case and he is custody for more than 70 days, this Court is inclined to grant bail to the petitioner with certain conditions. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.IV, Trichirapalli and on further condition that the petitioner shall stay at Madurai and appear before the Tallakulam Police Station daily at 10.00 a.m. for a period of two weeks.
