#### O R D E R

The petitioners approach this Court with a prayer to direct the learned Additional Sessions Judge for PCR Cases, Tirunelveli to consider and to pass orders on the bail application to be filed by the petitioners on their surrender on the same day in Crime No.150 of 2014 pending on the file of the respondent.

2.The petitioners are alleged to have committed an offence under Sections 147, 294(b), 452, 323 and 506(ii) I.P.C and 3(i)(x) of SC/ST Act (POA) 1989. It is stated by the petitioners that they are innocent persons.

3.The learned counsel for the petitioners would submit that the petitioners are prepared to surrender before the lower Court to co-operate with the prosecution and their petition for bail may be directed to be considered on the same day.

4.Learned Government Advocate (Cr1.side) would submit that the injured had discharged from the hospital.

5. This Court taking into consideration of the fact that by simply issuing a direction to the lower Court without going into merits, to dispose of the petition for bail on the same day, no prejudice would be caused to the prosecution, issues the following direction to the lower Court:-

"In the event of the petitioners surrendering before learned Additional Sessions Judge for PCR Cases, Tirunelveli and their filing of petition seeking bail, learned Additional Sessions Judge for PCR Cases, Tirunelveli, shall dispose of the said petition for bail on the same day strictly on merits and in accordance with law."



Accordingly, the Criminal Original Petition stands disposed of.
