ORDER

(Order of the Court was made by **S.MANIKUMAR, J.**)

Claiming himself to be the husband of the alleged detenue Kaviya, the writ of Habeas Corpus has been filed.

- 2. The petitioner has alleged the detention of his wife by respondents 3 to 5. The respondent No.3 is the father of the alleged detenue. The other two respondents are close relatives. Alleged detenue Kaviya is present.
- 3. When we enquired, the detenue submitted that she was born on 02.06.1992 and has completed B.Com., degree. Currently she is undergoing I.C.W.A. Course. When we enquired as to whether there was any detention or harassment by the respondents 3 to 5, she categorically denied. It is also her statement that she wants to go along with her father and https://hasersquestedes.govin/haserviews.d 5. As the allegation of detention is specifically denied by the alleged detenue, issuance of writ of Habeas Corpus does not arise.

4. Recording the statement of the detenue Kaviya, the Habeas Corpus Petition is dismissed. The alleged detenue is set at liberty.
