O R D E R

The delay on the part of the first respondent to consider the application submitted by the petitioner for approval of appointment of Mrs.T.Lavanya as Secondary Grade Teacher made the Management to file this writ petition.

2. The petitioner is a private aided school governed by the Tamil Nadu Private Schools Regulations Act 1973 and Rules made thereunder. The petitioner appointed Mrs.T.Lavanya as a Secondary



Grade Teacher against a sanctioned post. Thereafter the petitioner submitted a proposal before the second respondent for approval of appointment. The proposal was forwarded to the first respondent by the second respondent by proceedings dated 17.02.2014.

3. It is the grievance of the petitioner that the first respondent failed to consider the proposal resulting in filing this writ petition.

4. The first respondent is directed to consider and dispose of the application submitted by the petitioner for approval of appointment of Mrs.T.Lavanya, in the light of the proceedings dated 17.02.2014 on the file of the 2nd respondent. Such exercise shall be completed as expeditiously as possible, and in any case, within a period of three months from the date of receipt of a copy of this order.

The writ petition is disposed of with the above direction. No costs.
