Prayer:- Writ Petition filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus to direct the respondents 1 and 2 to reject the nomination paper of the $3^{\rm rd}$ respondent due to the violation of Election Rules mentioned by the $2^{\rm nd}$ respondent by the way of considering the petitioner's representation dated 26.08.2014.

- 3. Heard the learned counsel appearing for the petitioner and the learned counsel for the respondents 1 and 2.
- 4. This Writ Petition has been filed by the petitioner for issuance of a Writ of Mandamus to direct the respondents 1 and 2 to reject the nomination paper of the $3^{\rm rd}$ respondent due to the violation of Election Rules mentioned by the $2^{\rm nd}$ respondent by the way of considering the petitioner's representation dated 26.08.2014.

https://hcservices.ecourts.gov.in/hcservices/ to the petitioner, the third respondent's nomination is not acceptable and is liable to be rejected for various grounds.

6. The learned counsel for the Wakf Board submitted that the scrutiny of nominations is being done and if the petitioner has got any grievance, he can approach the Election Officer by way of proper representation.

7. In the light of the above stand, the writ petition is disposed of with the observation that it is open to the petitioner to approach the Election Officer by way of representation setting out all his grievance. No costs.
