# ORDER

This Writ Petition has been filed by the petitioner seeking for a direction to direct the respondent to revise the petitioner's seniority by placing the petitioner's name immediately below Thirumathi I.Seeniammal and retrospectively promote the petitioner with effect from the date of promotion of the petitioner's immediate junior with all consequent, monetary and service benefits.

- 2.Mr.V.Muruganandam, learned Additional Government Pleader takes notice for the respondent.
- 3.By consent, the writ petition itself is taken up for final disposal.
- 4. The learned counsel for the petitioner submitted that the date of appointment of the petitioner was wrongly entered as 01.09.1979 and subsequently, on 19.04.2007 the petitioner was promoted as Women Rural Welfare Officer and in the said proceedings, the date of joining was rightly found as 21.05.1979. But the names of the petitioner's juniors were considered for promotion. Therefore, the petitioner has given a https://hosepusecont.optin/poservites/ the respondent on 09.07.2012. The respondent has not considered the above said representation. Therefore, the present writ petition has been filed.

- 5. The learned counsel for the petitioner submitted that this Court may pass orders to consider the above representation given by the writ petitioner.
- 6. In view of the submissions made by the learned counsel appearing for the petitioner, this Court directs the respondent to consider the representation given by the writ petitioner on 09.07.2012 and pass necessary orders purely on merits within a period of six weeks from the date of receipt of copy of this order.
  - 7. With the above direction, this writ petition is disposed of. No costs.
