

**Prayer:** Writ Petition is filed under Article 226 of the Constitution of India praying for the issue of a Writ of Mandamus, directing the respondents to forbear the respondents from conducting night program in the event of Vaikasi Pongal festival at Marakkulam village by considering representation sent by the petitioner on 26.05.2014.

## **ORDER**

Heard the learned counsel appearing for the petitioners in both petitions and Mr.V.Muruganantham, learned Additional Government Pleader, who takes notice for the respondents in both petitions.

2. The writ petition in W.P.(MD) No.8602 of 2014 is filed by the petitioners to consider the representation given by the petitioner on 24.05.2014, in which, he seeks appropriate action against the Marakkulam village headman and to give protection for the petitioner's family while the Vaikasi pongal festival conducting by Marakkulam village.

- 3. The another petition in W.P. (MD) No.8609 of 2014 is filed by the petitioner to consider the representation given by him on 26.05.2014, in which, he seeks direction to the respondents to forbear the respondents from conducting night program in the event of Vaikasi Pongal festival at Marakkulam village by considering representation sent by the petitioner on 26.05.2014, since it will be created law and order problem.
- 4. Since both the representations were not considered by the respondents, the petitioners prayed for a direction to considering the above said representations dated 24.05.2014 and 26.05.2014 respectively.
- 5. The learned Additional Government Pleader appearing for the respondents in both petitions would submit that both the representations given by the petitioners are pending for consideration and the concerned officials have to consider the law and order problem which would be created in the above said village and then, they would pass suitable orders and in the meantime, the petitioners have been filed the writ petitions and therefore, the writ petitions may be disposed with direction to consider the said representations.
- 6.Admittedly, the representations given by the petitioners are only on 24.05.2014 and 26.05.2015 and within a few days, these writ petitions have been filed. Therefore, the concerned respondents are directed to consider the representations given by both the petitioners on 24.05.2014 and 26.05.2014 respectively and pass necessary orders on or before 03.06.2014.
- 7. With the above observation and direction, both the writ petitions are closed. No costs.
