ORDER

This Writ Petition has been filed for a direction to the respondents 3 and 4 to give adequate police protection to the petitioner and his family members' life and liberty for worshiping the God of Punitha Saveriyar during the Car Festival scheduled to https://hbevicebeck.gov.n/hc32/vice05.2014 based on the resolution made in the Peace Committee Meeting dated 24.05.2014 and 18.05.2013 and also direction to the respondents 1 and 2 to take necessary action.

- 2. Mr.V.Muruganandam, learned Additional Government Pleader takes notice for the respondents.
- 3. By consent, the writ petition itself is taken up for final disposal.
- 4. The learned counsel for the petitioner has submitted that the petitioner has given a representation dated 25.05.2014 to all the respondents. But, order has not been passed on the said representation. Therefore, he prays to consider the representation dated 25.05.2014 by the respondents.
- 5. The learned Additional Government Pleader appearing for the respondents reported that the representation is given only on 25.05.2014.
- 6. Admittedly, the petitioner has given a representation only on 25.05.2014 before the concerned authorities.
- 7. In the above said circumstances, the second respondent is directed to consider the representation of the petitioner dated 25.05.2014 and pass suitable orders on merits and in accordance with law, as expeditiously as possible.

The writ petition is disposed of accordingly. No costs.
