**ORDER:**

Aggrieved by the order of rejection of three documents bearing P.Nos.3 of 2014, 4 of 2014 and 5 of 2014, presented by the petitioner concerned land to an extent of Ac. 12.20 guntas, in Survey No.67/7B, situated at Yellakkapet Sivar of Kistampet Gram Panchayat in the then Chennur Taluk of Adilabad District. The petitioner filed appeal before the District Registrar, Adilabad District, Adilabad (3<sup>rd</sup> respondent) on 11.04.2014. The grievance of the petitioner insisting institution of this writ petition is that the appeal is not dispose of so far and on account of the delay in disposal of the appeal, grave prejudice is caused to the petitioner.

2. Having regard to the submissions made, without expressing any opinion on merits, if the District Registrar, Adilabad District, Adilabad (3<sup>rd</sup> respondent) has received the appeal against the orders of the Sub-Registrar, Mancheri, Adilabad District (4<sup>th</sup> respondent) and if the appeal is not disposed of so far, he shall pass appropriate orders on the appeal filed by the petitioner and communicate the same to the petitioner within a period of four (4) weeks from the date of receipt of a copy of this order.

3. With the above observations, the Writ Petition is disposed of. There shall be no order as to costs. Miscellaneous petitions, if any, pending in this writ petition, shall stand closed.
