Petition under Section 438 of Cr.P.C., praying that in the circumstances stated in the petition and grounds filed herein, the High Court may be pleased to grant anticipatory bail to the petitioner in the event of his arrest in connection in Crime No. 3 of 2013 of CID Police Station, Hyderabad on such terms and conditions.

THE COURT MADE THE FOLLOWING ORDER

"The petitioner is A-8. He seeks for grant of anticipatory bail. The petitioner allegedly committed offences under Sections 409, 420, 468, 471, 477-A, read with Section 120-B of IPC and under the provisions of Prevention of Corruption Act.

The petitioner is 86 years old. Earlier, he sought for grant of anticipatory bail through Crl.P.No. 12637 of 2013 and the same was dismissed by this Court. In the present anticipatory bail application, the learned counsel for the petitioner submitted that the petitioner has been suffering from cancer and several other ailments including kidney trouble and that these facts and circumstances had not been brought before the Court in the earlier bail application. They do not indeed constitute different circumstances, but however it is evident that these facts had not been brought to the notice of the Court by the petitioner in the earlier bail application.

In view of the nature of the offences alleged against the petitioner and in view of the age of the petitioner, I consider it appropriate to enlarge the petitioner on anticipatory bail.

Consequently, this petition is allowed. The petitioner shall surrender before the Chief Metropolitan Magistrate, Visakhapatnam, within two weeks from today. On such surrender, the learned Judge shall enlarge the petitioner on bail on a personal bond of Rs. 10,000/- (Rupees Ten Thousand Only) with two sureties in a likesum to his satisfaction. The petitioner is released on the specific condition that he shall cooperate with the investigation."
