The petitioners have approached this Court against the order dated 30.1.2014 (Annexure P6) passed by the District Magistrate-respondent No.2 whereby the petitioners were directed to give a sum of ₹15,000/- per month along with the electricity and water charges to the applicant-Shri Puran Singh Uppal, father of petitioner No.1.

During the pendency of this writ petition, the parties were relegated to appear before the Mediation and

- 4. That Ajit Singh-petitioner No. 1 shall withdraw
