Learned Advocate General, appearing for the respondent-State, informed this court that in respect of the appellant-Institutions viz., A.N.Industrial Training Centre, Runthala Industrial Training Centre, Shree Agrasen Development & Educational Training Institute and Shree Krishna Industrial Training Centre, after inspection chargesheet is proposed to be filed and the matter is pending for prosecution sanction. However, in the joint inspection, it is found that the appellant-Institutions viz., A.N.Industrial Training Centre and Runthala Industrial Training Centre meet the requisite standards laid down by the National Council for Vocational Training and so far as the appellant-Institutions Shree Agrasen Development &

Educational Training Institute and Shree Krishna Industrial Training Centre are concerned, the investigation is still pending but in the joint inspection report, the committee has expressed its opinion that both these Institutions meet the requisite standards laid down by the National Council for Vocational Training.

In the light of the above, we are of the view that since the standards laid down by the National Council for Vocational Training have been metted out by all the appellant-Institutions, there appears to be no impediment at this stage in granting permissions to the appellant-Institutions to undertake admissions of the students and so far as the finding of guilt, if in case at a later stage in the investigation being undertaken by the Anti Corruption Bureau, the law will take its own course.

In these circumstances, we find no good ground to deny the appellant-Institutions for not admitting the students for the academic session 2014-15. The students which were admitted by the appellant-Institutions upto the extended date of 30.09.2014, which has been noticed by the coordinate Bench of this Court, in order dt.17.09.2014, the same may be considered and approved by the State Authorities subject to their satisfaction for admission being granted on or before 30.09.2014 and permit the students to pursue their studies in accordance with the law and the result of the examination of previous years of the said students may also be declared within a period of one week.

Consequently, all the special appeals, in these terms, stand disposed of.
