3. 30-10-2015 Heard learned counsel for petitioners, learned A.C. to Standing Counsel – 14 and Sri Amish Kumar, learned counsel, who has filed vakalatnama on behalf of respondent no. 11 to 13.

In the writ petition, petitioners have prayed for

directing the respondents to produce merit list and appointment letter of twenty nine Shiksha Mitra and after quashing the same, a prayer has been made for preparing a fresh merit list.

At the very outset, Sri Amish Kumar, learned counsel for the private respondents submits that the post of Shiksha Mitra has already been abolished. This submission was not disputed by learned counsel for petitioners.
