JUDGMENT AND ORDER (ORAL)

Heard Mr. M.Z. Ahmed, learned Sr. counsel assisted by Mr. A.M. Dutta, learned counsel appearing for the petitioner as well as Ms. P.S. Nongbri, learned counsel appearing for the respondents No. 2 and 3, Mr. S. Sen Gupta, learned GA appearing for the respondents No. 1 and 4 and Mr. P. Nongbri, learned counsel appearing for the respondents No. 6-226.

2. The main prayer sought for in the present writ petition is for quashing the impugned suspension order dated 16.03.2015 passed by the

respondent No. 2 i.e. The Secretary to the Executive Committee, Khasi Hills Autonomous District Council, Shillong. For easy reference the translated copy of the impugned suspension order dated 16.03.2015 annexed as Annexure-10 of the writ petition is quoted herein as under:

"OFFICE OF THE EXECUTIVE COMMITTEE KHASI HILLS AUTONOMOUS DISTRICT COUNCIL, SHILLONG.

No. DC.XXVII/Genl/80/2003-15/99 Dt. Shillong, the 16th March, 2015

NOTIFICATION (JINGPYNBNA)

By this Notification, it is hereby notified in the entire Hima Khyrim, that the Executive Committee, Khasi Hills Autonomous District Council, in the mean time has suspended (Suspension pending Enquiry) Shri. C.A. Diengdoh from his Sordarship of Shnat Raid Tynring as per the provision embodied in Section 9(3) of the "United Khasi-Jaintia Hills Autonomous District (Appointment of Chief and Headmen) Act, 1959" as notified up to now. Therefore, Shri Hamlet Mylliempdah, Myntri Hima Khyrim to take over charge temporarily the management and administration of Shnat Raid Tynring, Hima Khyrim together with some of the elders of Shnat Raid Tynring, and the confirmation of which will be done by this office.

This Order, shall take effect, from today, and shall be in operation till further Order.

By the Order, etc., Sd/-Secretary to the Executive Committee, Khasi Hills Autonomous District Council, Shillong".

- 3. An interim order dated 20.04.2015 was passed in the present writ petition, that there shall not be any order for confirmation of the impugned suspension order dated 16.03.2015.
- 4. It is the submission of the learned counsels appearing for the parties that the enquiry proceeding against the present writ petitioner is still continuing.

- 5. Mr. M.Z. Ahmed, learned Sr. counsel appearing for the petitioner submits that the complainants who filed the complaints against the present writ petitioner did not appear before the enquiry authority inspite of serving the notice to them. Mr. M.Z. Ahmed, learned Sr. counsel further contended that the enquiry proceeding against the petitioner should be completed as expeditiously as possible.
- 6. Ms. P.S. Nongbri, learned counsel appearing for the respondents No. 2 and 3 also fairly submits that the enquiry proceeding against the petitioner will be completed as soon as possible if there be cooperation from the side of the complainants and the present writ petitioner.
- 7. In the above factual backdrop, this writ petition is disposed of by directing the complainants to appear before the enquiry authority as and when necessary. It is also further directed that the petitioner shall also cooperate with the enquiry authority in conducting the enquiry. It is made clear that the whole exercise should be within a period of 3(three) months from the date of receipt of the certified copy of this judgment and order.
- 8. Writ petition stands disposed of with the above directions.
