Heard Mr. PT Sangma, learned counsel for the petitioners and Mr. ND Chullai, learned Sr.GA assisted by Mr. KP Bhattacharjee, learned GA appearing for the State respondents.

**2.** Mr. ND Chullai, learned Sr.GA appearing for the State respondents submits at the Bar that the present writ petitions are squarely covered by the common judgment and order of this Court dated 01.06.2015 passed in WP(C)No.30/2014, WP(C)No.158/2014, WP(C)No.159/2014, WP(C)No.160/2014, WP(C)No.161/2014, WP(C)No.162/2014 & WP(C)No.163/2014, which are similar with the present writ petitions.
