The petitioner has been made an accused for the offence registered under Sections 341/342/323/376/34 of the Indian Penal Code.

Heard learned counsel for the petitioner and learned counsel for the State.

Learned counsel for the petitioner has submitted that the petitioner is innocent and has falsely been implicated in this case. Learned counsel further submitted that the fardbeyan of the victim girl is unbelievable itself as the petitioner, his father and wife cannot be involved in the alleged offence. It is further submitted that the injury report also does not support the offence alleged and for no fault on his part, petitioner has been languishing in jail custody since 07.01.2015.

Learned A.P.P opposed the prayer for bail.

Looking to the facts and circumstances of the case, petitioner above named is directed to be enlarged on bail, on his furnishing bail bond of Rs.10,000/- (Rupees ten thousand), with two sureties of the like amount each to the satisfaction of learned Principal Sessions Judge, Giridih in connection with S.T. Case no. 113 of 2015.
