THE COURT MADE THE FOLLOWING:

ORDER

The petitioner herein is arrayed as accused No.54 in Crime No.114/2014 of Annigeri Police Station, for the offences punishable under Sections 143, 147, 148, 323, 324, 307, 302, 109, 504 and 506 read with Section 149 of I.P.C.

2. It is submitted at the bar that similarly placed co-accused persons have been enlarged on bail in CrI.P. No.100130/2015 (d.d. 30.01.2015). The prosecution does not allege overt act against the petitioner herein. Though there is some material on record about the complicity of this petitioner in the alleged offence, in the absence of any specific material against him bringing forth overt act at the time of the alleged incident, there is no impediment to enlarge the petitioner on bail.

3. The petition is allowed. Petitioner is enlarged on bail in Crime No.114/2014 of Annigeri Police Station, subject to following conditions :

- (i) Petitioner shall execute a self bond of Rs.2,00,000/- with two solvent sureties for the likesum.
- (ii) He shall not tamper with the prosecution witnesses.
- (iii) He shall mark his attendance before the Annigeri Police Station on every Saturday between 11.00 a.m. to 5.00 p.m. for first two months and thereafter every alternate Saturday for the next four months.
- (iv) He shall not leave the jurisdiction of the Sessions Court till the conclusion of trial without prior permission of the Court.
