The election to the Board of Directors of respondent No.4- Society is scheduled on 09.05.2015. In these writ petitions, the petitioners want this Court to interfere with the election process. The election notification is dated 23.04.2015 and the last date for filing of nominations is tomorrow i.e. 01.05.2015. In the light of the Full Bench

judgment of this Court in Nanjundaswamy vs. A.R.C.S. (ILR 1992 KAR 979), I decline to entertain these petitions with liberty to the petitioners to avail of the remedy of an election petition provided under the provisions of the Karnataka Co-operative Societies Act, 1959.

Petitions dismissed.
