2. This is a writ petition seeking a direction on the authorities to dispose of the application of the writ petitioner dated April 20, 2012, for grant of quarrying lease over an extent of 10 acres in Survey No.99 of Thimmalapura Village, Sandur Taluk, Bellary District.

3. Mr. Manjunath Hegde, learned advocate appearing for the petitioner, submits that the application of the petitioner is pending from April 2012, but the District Level Task Force for Single Window Clearance of granting quarrying lease has not yet taken any decision.

4. We dispose of this writ petition directing the authorities to consider and dispose of the application of the writ petitioner stated to have been filed on April 20, 2012, by November 15, 2015.

5. We make no order as to costs.
