#### **JUDGMENT**

The petitioner has approached this Court with the following prayer:

- "a) Issue a writ of mandamus or any other appropriate writ, direction or order directing the 2<sup>nd</sup> respondent to consider Ext.P4 application and to grant permission to utilize the lands for other purposes including construction of buildings."
- 2. The learned Special Government Pleader submits that Ext.P4 application preferred by the petitioner under the relevant provisions of the Kerala Land Utilization Order, will be considered and finalised within the shortest possible time.

The writ petition is disposed of, directing the second respondent to consider and pass appropriate orders on Ext.P4 in accordance with law, after giving an opportunity of hearing to the petitioner at the earliest, at any rate, within 'two

months' from the date of receipt of a copy of this judgment.

The petitioner shall produce a copy of the judgment along with a copy of the writ petition before the second respondent for further steps.
