<u>ORDER</u>

% 30.01.2015

- Writ petitioners in all these petitions are seeking hearing and 1. adjudication of their applications under Section 74(4) of the Delhi Land Reforms Act for declaration of bhoomidari rights in respect of the land which is alleged to be allotted to them by the Government under the Twenty Point Programme. The petitioners are also seeking injunction against their dispossession till the decision of their applications.
- 2. Learned counsels for the respondents have taken instructions from the concerned SDM. Learned counsels confirm that the petitioners' applications under Section 74(4) of the Delhi Land Reforms Act are still pending and the learned SDM has given them instructions that it would take about six months' time to adjudicate them. It is further submitted that the Gaon Sabha has filed proceedings under Section 86A of Delhi Land Reforms Act seeking ejectment of the petitioners which are pending before the SDM. It is further submitted that it would be appropriate that the petitioners' applications under Section 74(4) as well as the proceedings under Section 86A of Delhi Land Reforms Act be heard and decided together.
- Learned counsel for the petitioner has no objection to this course of 3. action.
- In the facts and circumstances of these cases, these writ petitions are 4. disposed of with the direction that the learned SDM shall expedite the

hearing of petitioners' applications under Section 74(4) of the Delhi Land Reforms Act as well as the proceedings under Section 86A of Delhi Land Reforms Act and endeavour to decide them in a period of six months. The pleadings of the parties be completed within a period of eight weeks.

- 5. Learned counsels for both the parties submit that the parties be directed to appear before the concerned SDM on a fixed date. Let the parties appear before the concerned SDM on 02nd March, 2015 when the learned SDM shall fix the dates for completion of pleadings and thereafter for hearing the matters.
- 6. Learned counsel for the petitioners submits that if any adverse orders are passed against the petitioners, they may be protected for a period of two weeks to enable them to avail the remedies available in law. Learned counsels for the respondents submit that the respondents do not take any coercive action during the period of limitation for filing the appeals.
- 7. The parties shall maintain status quo with respect to the possession of the properties till the adjudication of the petitioners' applications in terms of this occer.
- 8. Opp of this order be given *dasti* to counsel for the parties under signatures of Court Master.
