Cr. Misc. No. 58268 of 2015 stands dismissed as

Petitioners of Cr. Misc. No. 54149 of 2015 are facing

prosecutions punishable under sections 498A, 304B, 201, 120B/34 of the Indian Penal Code vide Sarmera P.S. Case No. 124 of 2014.

The brother of the victim lodged the case alleging that within five months of marriage of the victim with the brother of the husbands of the petitioners, she was done to death in a mysterious circumstances while she was at Sasural. There was dowry demand by the in-laws and on account of the nonfulfillment thereof, she was earlier tortured. The body was removed.

Contention of the petitioners is that they live separately. The victim was offered medical assistance and while being treated by the Doctor, she died. There was panchayati also in respect of the occurrence. One of the contentions is that the petitioners being lady members are not in a dominating position in the family and, as such, they deserve the privilege of anticipatory bail in the background that no independent witness has supported the allegation of torture or unnatural death within the precincts of Sasural. They have no criminal background as well.

In the event of arrest or surrender in the Court below within four weeks, the petitioners of Cr. Misc. 54149 of 2015 namely Sangita Devi, Kavita Devi and Urmila Devi are directed to



be released on anticipatory bail on furnishing bail bond of Rs.

10,000/- (ten thousand) each with two sureties of the like amount
each to the satisfaction of Sri Ranjan Kumar Mishra, Judicial
Magistrate, 1st Class, Nalanda at Biharsharif in Sarmera P.S. Case
No. 124 of 2014 subject to the condition as laid down under
Section 438(2) of the Cr.P.C. with the further following
conditions:

- (i) One of the bailers shall be the own/close family members of the petitioners.
- (ii) In case of framing of charge, the petitioners shall appear in person on each and every date fixed in the Court below. In case of default in doing so on two consecutive occasions without any cogent/satisfactory reason, the Trial Court shall have liberty to cancel the bail bond of the petitioners and secure their arrest in accordance with law.
