

# **CORAM: HONOURABLE MR. JUSTICE JYOTI SARAN** ORAL ORDER

2 31-03-2016 Heard learned counsel for the petitioners, learned counsel for the State and learned counsel for the State Election Commission.

In each of the writ petitions the petitioners are aggrieved either by the reservation of posts in the ensuing



Panchayat Election 2016 to be held under the provisions of the Bihar Panchayat Raj Act, 2006 (hereinafter referred to as 'the Act') and the election rules framed thereunder or by the procedure followed by the State Election Commission for categorication / allotment of the constitutencies. While challenging the procedure followed by the State Election Commission, the petitioners in some of the writ petitions have also questioned the order dated 17.12.2015.

I have heard learned counsel for the parties and perused the records. The issues raised in these batch of writ petitions regarding categorization / allotment of any electoral constituency in the Panchayat election came up for consideration in a batch of writ petitions arising from CWJC No. 2445 of 2016 and this Court in consideration of the arguments advanced by the parties and law on the subject has upheld the procedure adopted by the Commission for reservation of the seat and while doing so this Court also reserved liberty for the aggrieved to take recourse to election dispute in case the procedure so adopted has not been correctly applied. While majority of learned counsel appearing for the petitioners in the respective writ petitions do agree that the issues raised herein have been examined by this Court and stands covered by the judgment and order passed in CWJC No. 2445 of

2016 and analogous cases but it is also the argument of some of the learned counsel that the procedure so adopted has not been correctly applied. Now since this Court while upholding the procedure adopted by the Commission on the issue of reservation of post on its statutory application has also granted liberty to the aggrieved to take recourse to the remedy so available to them in law in case they are of the opinion that the pattern has not been correctly applied, I do not deem it necessary to reiterate the liberty so given which is already present in the judgment of this Court and thus these batch of writ petitions are accordingly disposed of in terms of the judgment and order passed in CWJC No. 2445 of 2016 and analogous cases together with the liberty granted thereunder.
