The present application has been filed for modification of the order dated 22.10.2016 passed in Cr. Misc. No. 45941 of 2016 for correcting the father's name of petitioner No. 2 Mahendra Sahani as Late Ramnandan Sahani instead of Late Ramadhar Sahani.

The petitioner Mahendra Sahani and Ram Karan Sahani were granted anticipatory bail vide order dated 22.10.2016 passed in Cr. Misc. No. 45941 of 2016, in connection with Minapur P.S. Case No. 298 of 2012 registered under Sections 302, 201, 120B/34 of the Indian Penal Code. The father's name of petitioner No. 2 was wrongly perpetuated in the order since it was wrongly mentioned in the main petition as well as Vakalatnama.

It is submitted by learned counsel for the

petitioner that now a fresh Vakalatnama with correct father's name of petitioner No. 2 as Late Ramanandan Sahani has been filed.

Learned counsel for the petitioner is permitted to make correction in the main petition.

In the circumstances, the order dated 22.10.2016 passed in Cr. Misc. No. 45941 of 2016 is modified to the extent that father's name of petitioner No. 2 Mahendra Sahani be read as Ramanandan Sahani instead of Ramadhar Sahani. The period of surrender is also extended for a further period of three weeks from the date of receipt/production of a copy of this order.

Accordingly the modification application is disposed of in connection with Minapur P.S. Case No. 298 of 2012, pending in the Court of learned Chief Judicial Magistrate, Muzaffarpur.
