PER COURT :-

1. The acquiring body has challenged the award passed U/Sec. 28-A of the Land Acquisition Act by the S. L. A. O.
2. Mrs. Bharaswadkar Patil, the learned counsel for the Petitioner strenuously contends that, in the proceedings U/Sec. 28-A of the Land Acquisition Act no proper opportunity was given to the Petitioner. The Petitioner had requested for time. There were numerous matters filed, say was filed in some matters, however, in some of the matters say could not be filed, the time was sought, no proper opportunity was given to the Petitioners. The learned counsel submits that, the applications U/Sec. 28-A of the Land Acquisition Act were not filed within prescribed period of limitation.

The land acquisition officer does not have jurisdiction and or power to condone the delay. The aspect of limitation has not at all been considered by the authority. According to the learned counsel, it appears that the proceedings are filed in the year, 2005 on the basis of the award passed by the Reference Court in the year, 1990. The learned counsel submits that, earlier the applications U/Sec. 28-A filed by the present Respondents were rejected on the ground of deficiencies. The writ petition was filed by the Respondents in this court, notice was issued to the present Petitioners in the said writ petition and subsequently the same are allowed. The deficiencies were cured after lot of delay. The Respondents cannot take advantage of their own wrong. The Respondents should not be given statutory benefit because of the delay on their part. According to the learned counsel, opportunity be given to the Petitioner to contest the said applications on merit.

3. We have heard the learned A. G. P. also who submits that, the applications U/Sec. 28-A were filed well within the prescribed period of limitation. They were part of the same award.

4. We have considered the submissions canvassed by the learned counsel for the respective parties.

5. We had called for the record and proceedings of one of the case. We have perused the said record and proceedings. From the said record and proceedings it appears that the present Respondents had filed applications U/Sec. 28-A of the Land Acquisition Act on 23rd / 29th October, 1990, the same was filed on the basis of the award passed by the Reference Court U/Sec. 18 of the Land Acquisition Act in L. A. R. No. 305 of 1984 decided vide judgment dated 29.07.1990. The application U/Sec. 28-A of the Land Acquisition Act is required to be filed within 3 months of the award passed by the Reference Court U/Sec. 18 of the Land

Acquisition Act. In view of that the applications U/Sec. 28-A were filed within the prescribed period of limitation. The said aspect has been considered by the authority.

6. It is not the case of the present Petitioner that the acquisition of the land of the Respondents is not pursuant to the same award or for the same purpose as that of the applicant in L. A. R. No. 305 of 1984.

7. The acquisition of the land of the present Respondents is pursuant to the same award as that of the applicant in L. A. R. No. 305 of 1984. The Respondents were entitled to take the benefit of Section 28-A of the Land Acquisition Act. It is also not disputed that these Respondents had not filed Reference U/Sec. 18 of the Land Acquisition Act. The S. L. A. O. while deciding the applications U/Sec. 28-A of the Land Acquisition Act had considered the said aspect and has awarded the same compensation as was awarded by the Reference Court in a Reference filed U/Sec. 18 of the Land Acquisition Act.

8. It is not the case that no opportunity was given to the Petitioner herein. The Petitioner was issued notice and they had appeared in the said proceedings U/Sec. 28-A of the Land Acquisition Act even time was given to the present Petitioner. On perusing the record and the judgment of S. L. A. O. it is manifest that no illegality has been committed by S. L. A. O. while passing impugned judgment.

9. There is another facet to the present case also. The award U/Sec. 28-A of the Land Acquisition Act has been passed in December, 2011 and the present Petitions are filed in December, 2014 i.e. after lapse of 3 years. For a period of 3 years the said award passed U/Sec. 28-A of the Land Acquisition Act was never

assailed by the present Petitioner. It is also submitted that the Petitioners have not yet paid the amount under the award passed by the Special Land Acquisition Officer U/Sec. 28-A of the Land Acquisition Act. Almost 5 years have lapsed since the date of award being passed by the Special Land Acquisition Officer U/Sec. 28-A of the Land Acquisition Act. The Respondents are not getting the fruits of the said award. The enhanced amount of compensation is also only Rs. 3000 to 6000 in each matter, however, as the amounts are not being paid the interest is mounting every day at the rate of Rs. 15% per annum.

10. Considering the fact that the S. L. A. O. has considered all the relevant aspects no case for interference is made out. The Writ Petitions as such are dismissed. No costs.
