These Writ Petitions are filed under Articles 226 & 227 of the Constitution of India, praying to set aside only the portion of the order dated 14.2.2011 passed by the first respondent at Annexure 'D', etc.

These Writ Petitions coming on for Final Hearing this day, the Court passed the following:

ORDER

I have heard the learned Counsel for the petitioners and learned AGA appearing for R1 and R3. The other respondents are not represented.

2. This Court in W.P.No.15939/1993 disposed of on 27.1.2005 had quashed the order of the Land Tribunal dated 22.6.1982 granting occupancy rights to an extent of 20 guntas of land in Sy.No.98 of Varthur Village in favour of R.Narayanappa and the matter was remitted back to the Land Tribunal for fresh disposal in accordance with law. The Land Tribunal by order at Annexure 'D' dated 14.2.2011 has again considered the application filed in form No.7 in its entirety for grant of occupancy rights and has rejected the claim of the petitioners. This order is contrary to the order of this Court in W.P.No.15939/1993 dated 27.1.2005. The Land Tribunal ought to have confined the application to an extent of 20 guntas of land in Sy.No.98 of Varthur Village.

Therefore, the order at Annexure 'D' dated 14.2.2011 is hereby quashed and the matter is remitted back to the Land Tribunal, Bangalore East Taluk, Bangalore, for fresh consideration in terms of the order in W.P.No.15939/2003 dated 27.1.2005. Writ petitions are disposed of accordingly. No costs.
