This Miscellaneous First Appeal filed under Section 173(1) of the Indian Motor Vehicles Act against the judgment and award dated 12.03.2012 passed in MVC No.989/2011 on the file of the Presiding Officer, Fast Track Court-I, Member, Additional MACT, Mysore has been referred to this Lok Adalat by the Hon'ble High Court under Section 20 of the Legal Services Authorities Act 1987.

This appeal coming on for conciliation this day, *BUDIHAL R.B. J.*, delivered the following:-

## **CONCILIATION ORDER**

The learned counsel for the appellant and the representative of the Respondent-Insurance Company along with its counsel are present.

- 2. This is a claimant's appeal as against the judgment and award passed by the Tribunal. By mutual consent of the parties, it is agreed for a lump sum of Rs.45,000/- (Rupees Forty Five Thousand only) in addition to the amount awarded by the Tribunal, in full and final settlement of the claim. A joint Memo is filed on behalf of the parties to this effect. The entire amount is ordered to be released in favour of the appellant-claimant.
- 3. Respondent No. 3 Insurance Company shall deposit the said amount before the Tribunal, within six weeks from the date of preparation of Award, failing which, the said amount shall carry interest at the rate of 9% p.a. from the date of default till the date of deposit.

4. This Miscellaneous First Appeal stands disposed of in terms of the joint memo. The award of the Tribunal shall stand modified accordingly.
