JUDGMENT

The petitioner claims to be the owner and in possession of certain properties as per Ext.P1. He submits that the above land is erroneously included in the data bank. Accordingly to the petitioner, it is a dry land and it was converted much before the enactment of the Act 28 of 2008.

- 2. The petitioner approached the Local Level Monitoring Committee by Ext.P3 to correct the entry in the draft data bank.
- 3. This Court is of the view that appropriate steps shall be taken by the Local Level Monitoring Committee on Ext.P3. The Local Level Monitoring Committee shall find out whether the land in question can be classified as paddy land or nilam or wetland as on the date of the enactment of the Act 28 of 2008. If it cannot be classified either as paddy

land or nilam or wetland, necessary correction shall be carried out in the draft data bank. Needful shall be done within two months from the date of receipt of the certified copy of this judgment. It is made clear that this exercise shall be made by the Local Level Monitoring Committee, if the draft data bank is not finally notified.
