# **JUDGMENT**

The petitioner's vehicle, an excavator, bearing Registration No.KL 58/3996, was seized on 23/04/2016. The seizure was effected on the ground that the activity carried on by the Excavator was in violation of provisions of the Kerala Conservation of Paddy Land and Wet Land Act, 2008.

2. The petitioner asserts that the land, in which the Excavator was operated, was not a paddy land and was a garden land. The petitioner also relies on Ext.P2 report of the

Village Officer and Ext.P3 report of the Junior Superintendent, Collectorate, who was specifically directed to inspect the land. Both the said reports, according to the petitioner, indicated that the land, from which the excavator was seized, is a garden land. The Senior Government Pleader learned on instructions submits that the matter was heard report of the Agricultural Officer is and awaited.

In such circumstance, the District Collector shall expedite the report of the Agricultural Officer and order shall be passed, looking at the report of the Village Officer and Junior Superintendent of the Collectorate, who had inspected the property on the specific direction issued by the Deputy Collector. The

final order shall be passed, at any rate, within one month from the date of receipt of a certified copy of this judgment.

The writ petition is disposed of.
