2. The relief claimed by the petitioner is against the cooperative society. It is well settled that writ petition against the co-operative society is not maintainable in view of the Larger Bench judgment in K. Marappan Vs. The Deputy Registrar of Cooperative Societies, Namakkal Circle, Namakkal and another (2006 (4) CTC 689). Hence, the writ petition fails and the same is dismissed. No costs.
