order dated 25.1.2014. It is submitted that the petitioner intends

to return to India and face the criminal proceedings launched

against him. However, he apprehends that he will be arrested

soon after, he returns to India.

Notice of motion to Advocate General Punjab. At the

asking of the Court, Ms. Sudeepti Sharma, DAG, Punjab,

accepts the notice.

As of date, the petitioner stands declared proclaimed

offender and, therefore, he cannot be granted the concession of

anticipatory bail. However, as he intends to return to India and

face the criminal proceedings, he can be granted transit bail so

that he is not arrested for a specific period of time and in the

meantime, he may surrender before the trial Court.

Resultantly, the petition is disposed of with a direction

that in case the petitioner returns to India on or before November

21, 2016, he be not arrested. In case, he returns to India before

the said date, he shall surrender before the trial Court on or

before November 23, 2016 and then apply for regular bail, which

application shall be decided in accordance with law.
