BY THE COURT

Identical questions of facts and law were also raised in a batch of writ applications at Principal Seat, Jodhpur lead case being S. B. Civil Writ Petition No. 6272/2016 and the co-ordinate Bench at Jodhpur made a

detailed order on 30.5.2016 vacating the interim orders and the orders of status quo, permitting the State-respondents to proceed with the counselling.

In these matters, learned counsel for the parties were heard at length and this Court intended to proceed on the same lines i.e. order dated 30.5.2016. However, since learned counsel for the parties agreed for final disposal of the matters keeping in view of the directions as detailed out under Para 14 of the order dated 30.5.2016; wherein State-respondents have been directed to constitute a three member Committee within a period of three days to look into the grievances of the petitioners. The petitioners therein have been allowed liberty to address comprehensive representation(s) to the Committee within a period of two days of constitution of the Committee for redressal of their grievances. The functioning of the Committee is to be notified on the official website of the respondent Department. Furthermore, the representations have been ordered to be decided within a period of three weeks.

In view of the above, the matters were taken up for final disposal at this stage.

The co-ordinate Bench at Jodhpur vide order dated 30.5.2016, has issued directions under Paragraph 14,

which reads thus:

'14. An argument has been raised that some of the teachers who are teaching specialised subjects have been posted to such place where there is no such subject available or level-II teachers have been posted as Level-I. These grievances need to be redressed. In view of the submission made herein, it is directed that the Committee of three persons be constituted within a period of three days to look into such grievances as may be raised by the petitioners. The petitioners are at liberty to file their representation in this regard to the Committee within a period of two days of constitution of the Committee for Redressal of their grievances. Let the functioning of the committee and sitting be notified on the website of the department. In case the grievance is genuine the committee is directed take appropriate corrective steps. The representations are to be decided within a period of three weeks."

Accordingly, the petitioners herein are directed to address comprehensive representation(s) to the Committee, which is to be constituted in compliance to the order dated 30<sup>th</sup> May, 2016. The Committee, as directed vide order dated 30<sup>th</sup> May, 2016, would consider the representations of the petitioners and pass detailed speaking and reasoned order in accordance with law.

Needless to observe that the petitioners, if still aggrieved of the order that may be passed on their representations, would be at liberty to avail of legal remedy, in accordance with law.

With the observations and directions as indicated

above, the writ applications stand disposed off.
