Contention of learned counsel for the petitioner is that Government of Rajasthan has introduced a ST Package of Practice Scheme for providing financial assistance to the unemployed youth of the Scheduled Tribes for generating economic resource for self employment. As per the scheme, Government will provide financial help in the form of bank loan out of which 50% or Rs.10,000, whichever is less shall be the Government subsidy/grant

and remaining amount shall be the bank credit. About eight months ago, petitioner applied for loan under the said scheme. The Project Manager, Rajasthan SC & ST Finance and Development Cooperative Corporation Ltd., Dausa on 15.2.2016 has sent a letter to the Branch Manager, Punjab National Bank, Branch Sanwasa, Tehsil Lalsot, District Dausa to sanction loan applied by the petitioner and sent to the district office for grant of loan as soon as possible. However, the loan has not been granted to the petitioner. Petitioner contacted many times to the respondents and thereafter sent a legal notice on 4.5.2016, but the respondents have completely denied the loan application of the petitioner and the letter dated 15.2.2016.

Having regard to the facts aforesaid, instead of directly entertaining the writ petition, petitioner is set at liberty to approach the Branch Manager, Punjab National Bank, Branch Sanwasa, Tehsil Lalsot, District Dausa, who shall consider the request of the petitioner for grant of the loan under the said ST Package of Practice Scheme in terms of the order issued by Rajasthan SC & ST Finance and Development Cooperative Corporation Ltd., Dausa on 15.02.2016 or otherwise give reasons for not doing so and convey their decision to

the petitioner within two months of petitioner's approaching him along with copy of this order.

The writ petition is disposed off accordingly.
