Assailing the legality and validity of the order dated 18.10.2016 rendered by the District Collector, East District at Gangtok in exercise of power under Section 14 of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (for short, 'SARFAESI Act, 2002), learned counsel appearing for the petitioners submits that the petitioners, in the light of judgment and order dated 12.03.2015 passed by a Division Bench of the High Court of Judicature at Madras in Writ Petition No. 18365 of 2014 and M.P. Nos. 1 and 2 of 2014 : M/s G.K.K. Exports Pvt. Ltd. vs. Phoenix ARC Private Limited, following the law settled by the Supreme Court in Kanaiyalal Lalchand Sachdev and Others vs. State of Maharashtra and Others: (2011) 2 SCC 782, be permitted to withdraw this writ petition with liberty to

move the Debt Recovery Tribunal under the provisions of

Section 17 of the SARFAESI Act, 2002.

Learned counsel appearing for the Bank fairly

submits that since there is a statutory remedy available

under the SARFAESI Act, 2002, the petitioners may be

granted some time to take recourse to the statutory

alternate remedy.

This petition is, accordingly dismissed as withdrawn

with liberty to take recourse at appropriate forum.

Considering the location of secured assets in two States

namely, Sikkim and West Bengal, the dispute is amenable

to DRT jurisdiction at Guwahati as well as Kolkata. The

appeals may be filed, if so advised, within a period of four

weeks from today.

Status quo as obtained today shall be maintained by

all the parties for the said period.

In view of the aforestated order, no order is

necessary in IA No. 02 of 2017, application for seeking

impleadment.
