03/29.08.2017 In the present writ petition, the petitioner is seeking issuance of an appropriate writ/order/direction upon the respondents particularly respondent no.6 for providing adequate and proper security to the petitioner and his family members.

Learned counsel has also filed supplementary affidavit annexing therein the recommendation of the Officer-in-charge, Boragarh O.P. who, by his letter dated 07.08.2017, has reported that there is threat to the life and property of the petitioner and his family members.

Learned counsel for the petitioner has submitted that petitioner has filed representation vide Annexures-3 and 4 dated 27.12.2014 and 24.12.2015 respectively, before the Superintendent of Police, Dhanbad, copy of which has also been sent to the Director General of Police, Jharkhand and other higher officials of the Government but till date no decision has been taken on the representation of the petitioner.

3. Learned J.C. to A.G has submitted that in terms of Circular No.1374 dated 11.03.2003 and amendments made in the Circular,

the Department of Home, Government of Jharkhand has laid down the guidelines to be followed for providing security to the persons who are facing serious threat to their life and property. That the security can be provided by the competent authority in accordance to the prescribed guidelines by the Circular.

4. Heard. The petitioner is at liberty to file fresh representation before the Sr. Superintendent of Police,Dhanbad annexing therein the relevant documents for providing adequate security to him and his family members. The Sr. Superintendent of Police,Dhanbad shall pass necessary order in terms of the aforesaid Circular at the earliest, preferably within eight weeks from the date of receipt of the representation.

5. With the said observation/direction the writ petition stands disposed off.
