02/31.08.2017 Heard the learned counsels appearing for the parties
and perused the documents on record.

The petitioner has been made an accused in Balumath
P.S. Case No. 72 of 2016, registered for offence under
Section 363 IPC and charge-sheet has been submitted under
Section 364A/34 IPC.

Referring to order granting bail to co-accused namely,
Sunil Ram and Md. Naushad @ Md. Nausad vide B.A.
No. 4981 of 2017, the learned counsel for the petitioner
submits that there is no allegation of demand of ransom and
while so, ingredients for offence under Section 364A is not
made out. The petitioner is in judicial custody since
17.04.2017 and charge-sheet has already been submitted.

Mr. Anand Kumar Pandey, the learned APP has
opposed the prayer for grant of bail.

Having regard to the aforesaid facts and circumstances
of the case, the petitioner namely, Deepak Ram @ Deepak
Kumar Ravi is directed to be released on bail on furnishing
bail bond of Rs.10,000/- (Rupees ten thousand) with two
sureties of the like amount each to the satisfaction of the

learned Chief Judicial Magistrate, Latehar in connection with Balumath P.S. Case No. 72 of 2016 corresponding to G.R. No. 315 of 2016, on the following conditions :

- (i) one of the bailers shall be Class-I legal heir of the petitioner provided not wanted in any other criminal case,
- (ii) he shall remain physically present on each and every date during the trial, except for special circumstances, in which the petitioner shall move an appropriate application in the trial court seeking exemption from appearance,
- (iii) he shall not change his place of residence without prior permission of the Court, and
- (iv) he shall file his attendance in the Balumath Police Station on every Sunday between 9.00 a.m. to 10.00 a.m. and a report in this regard and on his conduct shall be forwarded from the office of the Superintendent of Police, Latehar to the trial court every month.

On breach of any of these conditions, the investigating officer shall file an application for cancellation of bail in this Court.

The instant application is allowed. Let a copy of the order be transmitted to the trial Court and the Superintendent of Police, Latehar through 'Fax'.
