The petitioners are accused in a case registered under Sections 302/34 of the Indian Penal Code.

Learned Counsel for the petitioners submits that the petitioners have been falsely implicated in the present case and have not committed any offence as alleged in the F.I.R. It is further submitted that petitioners have been arrested by the police on the basis of doubt but except raising doubt the concerned police have no material evidence against them. It is lastly submitted that no incriminating articles have ever been recovered from the possessions of the petitioners. Moreover, the petitioners are in custody since 14.10.2016 and hence, they may be granted the privilege of regular bail.

Learned A.P.P. opposes the prayer for bail.

In the facts and circumstances of the case, the petitioners are directed to be released on bail on furnishing bail bond of Rs.10,000/- (Ten thousand) each with two sureties of like amount each to the satisfaction of the Learned Chief Judicial Magistrate at Chaibasa in connection with Jhinkpani P.S. Case No.28 of 2016, corresponding to G.R.No.430 of 2016.
