*(RAJ BAHADUR SINGH Vs THE STATE OF MADHYA PRADESH)*

Invoking the jurisdiction under Article 226 of the Constitution of India and assailing the impugned orders dated 22.9.2012, 22.9.2012, 22.9.2012, 22.9.2012, 22.9.2012, 14.5.2012, 30.10.2012, 10.1.2013, 10.1.2013, 10.1.2013, 10.1.2013, 10.1.2013, 24.6.2013, 24.6.2013, 24.6.2013, 30.12.2014, 31.10.2014, 24.12.2014, 30.10.2015, 21.3.2016, 11.3.2016, 11.3.2016, 30.10.2015, 25.6.2016 passed by the Collector, District Sidhi, the order dated 20.10.2014 passed by Sub Divisional Officer Gopad Banas Sihawal, District Sidhi, the order dated 28.9.2015 passed by Manager Krishak Sewa Sahkari Samiti Maryadit Semaria, District Sidhi, the order dated 2.12.2015 passed by Manager Krishak Sewa Sahkari Samiti Maryadit Patehara, District Sidhi so also the impugned orders dated 8.8.2016 and 8.8.2016 passed by Deputy Commissioner Sahkarita, District Sidhi respectively as per sequence of the writ petitions as mentioned in the cause title of this order, the petitioners, who are salesmen, have filed these petitions.

2. The issue involved in the present cases has already been decided by this Court by passing a detailed order on 31.3.2017 in Writ Petition No.13958/2016 {Suresh Patel Versus State of M.P and another} and Writ Petition No.15046/2016 {Raj Bahore Tiwari Versus State of M.P and another}.

3. For the reasons stated in the order dated 31.3.2017 passed in Writ Petition No.13958/2016 and Writ Petition No.15046/2016, which are applicable to the facts of the present cases and squarely cover the issue

involved, these petitions succeed and are hereby allowed in part. The respondents are at liberty to take action against the petitioners in accordance with law. In the facts and circumstances of the case, the parties shall bear their own costs.
