2. The case of the petitioner in the both the petitions is that they are in possession and cultivation of land in Sy.No.202/A measuring 1 acre 26 cents, situated at Ganakihal village, Ballari Taluk and District.

3. The petitioners have filed Form No.7A under the provisions of the Karnataka Land Grant Rules for grant of land. The same has not been considered. Hence, the petitioners seek direction to the respondents to consider the same and pass appropriate orders.

4. In the light of the prayer made by the petitioner in both the petitions and also the materials produced along with the petitions, the respondents are

directed to consider and pass appropriate orders on the Form 7A of the petitioners within a period of six months from the date of receipt of a certified copy of this order.

The writ petitions stand disposed of accordingly.
