THIS CIVIL PETITION IS FILED UNDER SECTION 24 OF CPC, PRAYING TO WITHDRAW THE PETITION FOR DIVORCE IN M.C.NO.30/2017 PENDING ON THE FILE OF FAMILY COURT, HUBBALLI, AND TRANSFER THE SAME TO THE FAMILY COURT, BELAGAVI, FOR DISPOSAL IN ACCORDANCE WITH LAW, ETC.,.

ORDER

Heard. Petitioner and respondent are husband and wife. Respondent has filed M.C.NO.30/2017 before the Family Court, Hubballi, for dissolution of marriage of himself and the petitioner on the ground of cruelty and desertion. In this petition petitioner seeks transfer of the said case from Family Court, Hubballi, to the Family Court, Belagavi, on the ground that she cannot afford to contest the matter at Family Court, Hubballi.

2. It is submitted that the petitioner has filed M.C.No.144/2017 before the Family Court, Belagavi, for restitution of conjugal rights. The counsel for the respondent files affidavit of the respondent conceding

for transfer of his petition as prayed by the petitioner.
The affidavit is recorded.

3. It is submitted that the marriage of the parties is solemnized in Belagavi and the petitioner is residing in Belagavi. Having regard to these facts the petition is allowed. M.C.No.30/2017 pending before the Family Court, Hubballi, is herewith withdrawn and transferred to the Family Court, Belagavi, for disposal in accordance with law. No order as to costs.
