1. Learned Government Advocate has produced before us, a memo along with a copy of the order dated 25.02.2017 passed by the Executive Engineer, National Highway Division, Hubballi, to the effect that the land in question does not belong to the present complainants/petitioners and therefore, compensation cannot be paid to them.

2. The direction of the learned Single Judge in the order dated 08.07.2016 was that “if the conclusion is that the land of the petitioners has been utilized and the petitioners are to be compensated, the authority to pay the compensation shall also pay the compensation as expeditiously as possible thereafter”.

3. In view of the aforesaid, we do not find any deliberate disobedience on the part of the accused -
