This writ petition is filed under Article 226 & 227 of the Constitution of India, praying to issue a writ of certiorari quashing the Award passed by the Presiding Officer, Labour Court at Gulbarga in KID No.59/2012 dated 07.01.2013, at Annexure-B to the writ petition and allow the Claim petition.

This Appeal being referred to Lok-Adalat coming on for Conciliation this day, the Lok Adalat made the following:-

CONCILIATION ORDER

The learned counsel for the petitioner and the representative of Respondents-KSRTC along with its counsel are present.

2. After prolonged negotiations, the matter is settled. The petitioner has agreed for reinstatement into service without backwages, without continuity of service withholding of five ensuing annual increments with cumulative effect.

3. A joint Memo is filed on behalf of the parties which reads thus:

TERMS OF JOINT MEMO

1. The petitioner agrees for reinstatement into service without backwages, continuity of service and other consequential benefits from the date of dismissal till the date of his actual reinstatement, by withholding of ensuing 5 annual increments with cumulative effect.

2. The workman will not repeat the similar misconduct or other misconduct in future after his reinstatement and he has undertaken that he will serve the corporation honestly and sincerely in future.

3. Contents of this joint memo is read over and explained to the parties and they have agreed for the terms they have signed on the same.

The Writ Petition stands disposed of in terms of the Joint Memo.
