THIS PETITION COMING ON FOR PRELIMINARY HEARING-B GROUP THIS DAY, THE COURT MADE THE FOLLOWING:

ORDER

The present writ petition was filed for writ of certiorari to quash the impugned notification No.3/2013-14 dated 17.05.2013 inviting for tender through E-auction issued by the office of respondent No.3 at Annexure-G to the writ petition.

02. Sri.Amresh.S.Roja, learned counsel for respondents No.1 to 3 submits that after issuance of notice by this court on 31.05.2013 to the respondents, the Annexure-G was not pressed and time fixed for auction start date and auction end date already over on 27.05.2013 and 03.06.2013 respectively.

03. In view of the same the prayer sought for in the petition does not survive for consideration.

04. The said submission is placed on record.

In view of the same, writ petition is disposed of as it does not survive for consideration with a liberty to petitioner to pursue his remedy in accordance with law, if such notification issued in future.
