# ORDER

In these writ petitions, the petitioners are seeking a writ of mandamus, directing the respondent No.4 to admit their children in LKG class for the academic year 2014-15 and to enforce Right to Education Act, 2009.

2. This Court by Order dated 21.11.2014 rejected the interim prayer sought by the petitioners. Hence, the reliefs sought for by the petitioners is to admit the students for the academic year 2014-15 and the said academic year being completed, the writ petitions do not survive for consideration.

Accordingly, the writ petitions stand dismissed as having become infructuous.
